## FREQUENTLY ASKED QUESTIONS AND ANSWER SHEET

Ocean Sands Condominium Association, Inc.

**Q: What are my voting rights in the condominium association?**

A: All of the joint unit owners shall be entitled collectively to only one (1) vote in Association affairs.

**Q: What restrictions exist in the condominium documents on my right to use my unit?**

A: Units are for Residential use only.

**Q: What restrictions exist in the condominium documents on the leasing of my unit?**

A: The minimum period for renting or leasing your unit is 14 days. No pets.

**Q: How much are my assessments to the condominium association for my unit type and when are they due?**

A: Monthly assessments, based on unit size, are determined each year when the budget is approved. They are due the first day of the month; late fees apply. The amounts are listed in the budget and posted on the OurOceanSands.com website.

**Q: Do I have to be a member in any other association? If so, what is the name of the association and what are my voting rights in this association? Also, how much are my assessments?**

A: Not applicable

**Q: Am I required to pay rent or land use fees for recreational or other commonly used facilities? If so, how much am I obligated to pay annually?**

A: The only common area use fee is a refundable \$25.00 deposit for use of the Tiki Decks.

**Q: Is the condominium association or other mandatory membership association involved in any court cases in which it may face liability in excess of \$100,000? If so, identify each such case.**

A: The condominium association is not involved in any such action.

In accordance with Article VI, Section 7, Subsection B of the By-Laws, addressing the right to vote, which states:

"Membership may be held in the name of more than one (1) person, corporation or other entity. In the event ownership is in more than one (1) person, corporation or other entity, all of the joint owners shall be entitled collectively to only one (1) vote in the management of the affairs of the Association and said vote may not be divided between multiple owners. All owners shall file a certificate with the Secretary naming the person ("voting member") authorized to cast said Unit vote. A new certificate shall be filed prior to or at any meeting of the members annual or special; if such certificate is not on file, the vote of such Unit shall not be considered, nor shall the presence of said Owners at a meeting be considered in determining whether the quorum requirement has been met.
